THE TRAINING GRANT - OVERVIEW

NJ Dept of Labor and Workforce Development (DOL) Skills Partnership Training Grant

- **Maximum: \$250K/consortium; \$100K/agency**
- **Most Courses/Topics are Covered**
- **Training by 3rd party or employee-trainers**
- **Grants for a 12 month period**

THE TRAINING GRANT APPLICATION

- **Electronic Application, Forms and Essays**
- **Criteria:**
 - **No outstanding obligations with the state**
 - **“Demonstrated financial need”**
- **Can be individual or with a consortium**
 - **Headcount >200/more control – individual**
 - **Headcount <200/less effort - consortium**

NEXT STEPS

- **Talk to fellow members/grantees**
- **Phone Call/Meeting:**
 - **Assess if and how much you are qualified**
 - **Decide if apply individually or in consortium**
 - **If consortium, talk to Act-Cess**
 - **Do a training needs assessment**
 - **Start the grant application**
 - **This June**
 - **FY2020**
