**Community Behavioral Health Clinics**  
**Achieving Success in Integrated Services**

In 2017 New Jersey was one of 8 states selected to participate in a two year demonstration project to provide services through Certified Community Behavioral Health Clinics (CCBHCs). CCBHCs are especially designated to provide comprehensive mental health and substance use disorder services uniquely integrating behavioral health with physical health care. Panelists from three CCBHC providers: **Catholic Charities of Trenton, Oaks Integrated Care, and Rutgers Behavioral Health Care** will discuss successful outcomes, lessons learned and how this coordinated care effort can transform service delivery for the future.
